Subject: Speakman Long-Term Care Home - Paid Parking Update

Dear residents,

My name is Tess Romain, President of Partners Community Health (PCH) – the organization that will be operating the new long-term care homes on 2180 Speakman Drive in Mississauga. I am writing to introduce myself and share an update on a recent decision related to parking at the long-term care homes.

Working closely with Trillium Health Partners (THP) and EllisDon (ED), I know the community has raised concerns about paid parking at the long-term care homes and the impact this may have on neighbouring streets. This was also a topic of discussion at the recent town hall in April 2022.

Paid parking is a source of revenue for many health care organizations as it generates funds to reinvest into patient or resident care. The option for paid parking at the Speakman Drive long-term care homes was built into the development plans.

As a community partner, we value your feedback. In preparation for our 2023

opening, PCH has completed a parking assessment. The results of this assessment, which included review of other long term care homes' practices, impact on revenues, community and staff feedback, has resulted in the decision not to implement paid parking for staff and visitors at 2180 Speakman Drive at this time.

Upon completion of the long term care homes, there will be over 300 parking spots – which far exceeds the City of Mississauga parking requirements.

We are also aware of the feedback regarding the gate access at Fowler Lane. As we have made the decision not to implement paid parking, we plan to leave the gate unlocked. Once the LTC homes have opened, we will monitor any concerns.

Thank you for sharing your feedback as we arrived at this decision. We, at PCH, look forward to working closely with you as part of your community.
